

# Limited Warranty

The start of the warranty period is the documented date of your purchase of the Product. The warranty period on a repaired or replacement Product is the remainder of the warranty on the original Product or 30 days, whichever is longer.

If you discover a defect in material or workmanship during the warranty period, and Arrow Tru-Line agrees that the defect exists, Arrow Tru-Line will, at its sole option, repair or replace the Product at no charge to you. Arrow Tru-Line may require a proper proof of purchase documentation prior to performing a repair or issuing a replacement Product.
