



Limited Warranty Monument Garage Doors

Apple Door Systems shall warrant its Monument Collection garage door sections to be free from defects in materials and workmanship and installation labor for a period of 2 years from the date of installation. This warranty shall apply to all Monument Collection doors provided: door sections are to be finished on all surfaces with Sikkens (for stain grade models) or painted with two coats of oil-based exterior primer and one coat of top quality exterior paint prior to exposure to weather (for paint grade models, second coat to be applied within two weeks of install date). All other components are warranted to be free from defects in workmanship and material for a period of one (3) years from date of installation. Purchaser understands that Monument Collection garage doors are manufactured for Apple Door Systems by Artisan Custom Doorworks of Morgantown, Pennsylvania and that manufacturer's warranty shall support but not supersede the limited warranty stated herein.

This Limited Warranty applies only to garage door sections manufactured for Apple Door Systems and components manufactured or supplied for Apple Door Systems. The warranty excludes: (1) Sections and/or component parts which have been damaged due to misuse or improperly finished or maintained; (2) Sections and/or components which have been improperly installed; (3) Sections and/or components that have been damaged due to accident; (4) Sections and/or components that have been damaged due to exposure to corrosive fumes/chemicals, alkaline cleaning agents, condensation or fire; (5) Performance of coatings used to finish the garage door sections; (6) Repair and/or replacement labor charges, including travel cost; (7) Damages resulting from other causes beyond the manufacturers control (8) normal wood behaviors due to contraction and expansion of wood, such as checking, cracking, and leaking sap pockets which are all natural reactions of wood due to changes in humidity levels.

In the event any defect is claimed during the warranty periods, a claim in writing must be submitted to Apple Door Systems. This claim must be submitted within fifteen (15) days of the discovery of the suspected defect. The door and all components must be available for inspection by an authorized Apple Door Systems representative. Upon verification of a manufacturing defect, Apple Door Systems will provide repair or replacement part(s) at its option.

APPLE DOOR SYSTEMS SHALL NOT BE RESPONSIBLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING OUT OF ANY BREACH OF THIS EXPRESS LIMITED WARRANTY, including but not limited to any damage to buildings, other property or for any injuries or damages sustained by any person whomsoever, or the recovery of any direct or indirect costs such as shipping, travel, lost time, installation labor charges, paint or painting, cleaning, repair, or other building materials.

This warranty gives you specific legal rights and you may also have other rights as provided by the state of Virginia. Apple Door Systems does not authorize anyone to change or modify the above warranties in any respect. **ANY IMPLIED WARRANTY OR MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE APPLICABLE TO MONUMENT COLLECTION GARAGE DOORS IS LIMITED IN DURATION TO THE DURATION OF THE APPLE DOOR SYSTEMS WRITTEN WARRANTY SET FORTH ABOVE AND NEITHER APPLE DOOR SYSTEMS NOR ANY AUTHORIZED SELLING DEALER SHALL BE LIABLE FOR LOSS OF TIME, INCONVENIENCE, COMMERCIAL LOSS, OR OTHER CONSEQUENTIAL OR INCIDENTAL DAMAGES.**
